ONLINE ADMISSION NOTIFICATION 2022-23-24

In pursuance of Directorate of Skill Development J&K's Admission Notice issued under endorsement No.DSD/401/Trgs/2022/592-680 dated:17-6-2022, Online applications are invited from the desirous candidates for seeking admission in Govt. ITI, Reasi for the academic session 2022-23-24 in various Engineering/Non- Engineering trades having duration of two years/One year for free, Self financing and PPP mode seats being run under NCVT/SCVT Schemes and commencing from Sept,2022 for which the forms can be uploaded from 18th of June, 2022.

The desirous candidates having minimum age of 14 years as on 1st June,2021 with no upper age bar have to fill up the admission forms available on line at ITI admission link (<http://itiadmissions.jkdsd.in>) present on the official website of Directorate of Skill Development J&K i.e. :-www.jkdsd.org.

The last date for applying online is upto 09th of July, 2022. The candidates shall have to fill up complete details which include basic details of student like, name, parentage etc. and qualification details online in the portal and have to upload the scanned copies in jpg format (with size between 50KB to 300KB) of the following documents online only.

- 1/ Marks certificates of qualifying examination.
- 2/ Date of birth certificate.
- 3/ Category certificate (SC/ST/Ex-Serviceman/Physically Handicapped/EWS if any.
- 4/ Aadhar card.

Domicile certificate should be produced at the time of admission in ITI Reasi.

The candidates after finalizing the profile and applications online will be required to deposit the printout of the system generated applications completed in all respects along with self-attested documents uploaded on the portal and deposit the prescribed fee of Rs.100/- (Rs. One hundred only) per three trades against a proper cash receipt from Govt. ITI Reasi.
